ATF's Mission Regarding Tobacco Diversion

- To disrupt and eliminate criminal and terrorist organizations who traffic in contraband cigarettes
- To conduct financial investigations in conjunction with criminal investigations to seize all assets derived from trafficking in contraband cigarettes
- To safeguard all legal licensed manufacturers who follow all applicable rules related to the manufacture and sale of cigarettes
- To assist in international state and local investigation and use ATF resources in order to throughly investigate and prosecute cigarette trafficking investigations.

Challenges For Law Enforcement

Corrupt Manufacturers

- MSA Escrow Fraud
- Low tax state to high tax states
- Native American Reservations used to divert
- Counterfeit Cigarettes and state tax stamps
- Hijackings/Organized
 Crime/Terrorism

Current Trends in Diversion

Two main area of discussion:

1. Unlicensed Cigarette Manufacturers

2. Diversion of cigarettes from low tax states and Native American Reservations to areas with high cigarette excise taxes

1. Unlicensed Cigarette Manufacturers.

- In New York there are over 10 federally unlicensed manufacturers
 - All located on Native American Reservation
 - The Akwesasne/St. Regis/Mohawk Reservation
 - All on the US Side of reservation

Problems regarding unlicensed manufacturers.

- Cost the Canadian and United States Governments Millions of dollars a month in excise tax
- No money paid in the the MSA. So we are stuck paying the bill for health related issues
- No regulations
- Counterfeit of major brands and other 4th tier products

ENFORCEMENT ACTIONS

PACT ACT

- New laws enacted by The Seneca Nation of Indians:
 - All cigarettes must be stamped with the Seneca Nation Import/export Stamp.
 - Illegal to sell more than 49 cartons of cigarettes in one transaction.
